## A. <u>INTRODUCTION</u>

1. Scope of Bid	1.1	National Disaster Management Authority (NDMA) invites Bids for Tender for Provision of SMD Video wall for National Emergencies Operation Center. As indicated in the <b>Bid Data Sheet</b> (BDS) and Section <b>V</b> – <b>Technical Specifications &amp; Schedule of Requirements</b> .  NEOC Pakistan has identified simultaneous challenges of water scarcity and extended cold weather conditions affecting multiple regions across the country. Accordingly, Pakistan is on the verge of facing serious water stress crises as changing climate conditions exacerbate droughts and depleted vital water resources. The melting of glaciers, driven by rising temperature, over extraction and mismanagement continue to deplete groundwater. Below average rainfall in multiple parts of country during ongoing winter season has impact on growth of rabi crops. Intensified severe heatwaves are predicted in the coming summers leading to increased frequency and severity of these issues. These compounded challenges, fueled by climate change, lead to emergency situation and warrant urgent attention to safeguard Pakistan's water food and environment security. Hence, the firms are required to install the SMD video wall on emergent basis to make it operational for the required purpose.

Supporting documents and printed literature furnished by the Bidder may be in another language provided they are accompanied by an accurate translation of the relevant pages in the English language unless specified in the <b>BDS</b> , in which case, for purposes of interpretation of the Bidder, the translation shall govern.
