## Section: II Instructions to Bidders (ITBs)

### A. INTRODUCTION

1. Scope of Bid	1.1	National Disaster Management Authority (NDMA) invites Bids for procurement of Software and Satellite Feed as indicated in the Bid Data Sheet (BDS) and Section V - Technical Specifications & Schedule of Requirements. The successful Bidders will be expected to deliver the Software and Satellite Feed and other requirements within the specified period and timeline(s) as stated in the BDS. The technical specifications / schedule of requirement consists of three items. The firms/companies may quote separate rates for each item in their proposal. However, they may opt for one or all items, as they can provide. The delivery time must be mentioned in financial proposals, alongwith cost of each item.
2. Source of Funds	2.1	National Disaster Management Fund/Project fund.
3. Eligible Bidders	3.1	A Bidder may be natural person, company or firm or public or semi-public agency of Pakistan. In the case of a joint venture, consortium, or association, all members shall be jointly and severally liable for the execution of the Contract in accordance with the terms and conditions of the Contract.
	3.2	The invitation for Bids is open to all prospective supplier, manufacturers or authorized agents/dealers subject to any provisions of incorporation or licensing by the respective national incorporating agency or statutory body established for that particular trade or business.

Non-attendance at the pre-Bid meeting will not be a cause for disqualification of a Bidder.
