Sub:- URGENT MEASURES TO COMBAT ANTICIPATED EXTRA-ORDINARY FLOOD SITUATION AT NOWSHERA, RIVER KABUL

Flood Forecasting Division (FFD), Lahore of Pakistan Meteorological Department has issued the following Flood Warning vide its Bulletin No. A-073/22 dated 26th August 2022.

"Very High to Exceptionally High level flooding is expected in River Kabul at Nowshera (upto 300,000 cusecs) and Tributaries of Rivers Kabul & Indus during next 48 hours. Severe flooding is likely to continue in Rivers/ Nullahs of Balochistan during next 24- hours"

The above anticipated Very High to Exceptionally High flood situation at Nowshera on River Kabul during the next 48 hours warrants extra-ordinary measures to be taken by WAPDA forthwith through its Dam Management Authorities at Tarbela Dam and Chashma Barrage.

Foregoing in view and in line with the telephonic discussions held with Chairman IRSA, Superintending Engineer (South), Superintending Engineer (North), Irrigation Department, Government of Khyber Pakhtunkhwa, Chief Engineer, Chashma Barrage and finally with your good-self, in order to manage Very High flood flows in Indus d/s Tarbela from Kabul at Nowshera, adequate peak absorption space in Chashma Barrage needs to be created immediately.

Necessary instructions in the above context may kindly be issued to Chashma Reservoir management under intimation to all concerned including this office.
