Subject: **ADVANCE FLOOD FLOWS INFORMATION FROM INDIA**

Pakistan Commissioner for Indus Waters (PCIW) has shared a Flood Alert on Advance Flood Flows Information from office of India commission for Indus Water that Tawi River at Jammu has entered into a flood regime with a flow of 80,950 Cusecs and is showing a rising trend. Forecasted flow level falls in **High Flood Category of 80000- 170000 cusecs**. Copy of PCIW Advance flood Flows Information dated 11 Aug 2022 is attached as Annex-A. All concerned Federal Ministries / Departments, PDMA Punjab, Punjab Irrigation Department, Respective District Administrations / DDMA's, Municipal / City Administrations are advised to ensure following:

- a. Identification of vulnerable points / at-risk communities and devise mitigation measures.
- b. Maintain enhanced alert level / monitoring of developing situation to reduce reaction / response times.
- c. All civic agencies / rescue services (Rescue 1122 / Fire Brigade/Ambulance/ Civil Defence) to remain alert and ensure availability of personnel and equipment during the next 24 hours, especially in at-risk areas.
- d. People living along the banks of Rivers Chenab and in vicinity of adjoining Nullahs to be sensitized about expected increase of water flows.
- e. Timely evacuation of at-risk population from low-lying / flood prone areas as per Evacuation Plans and availability of shelter, food and medicines in those shelter camps.
- f. Locals / farmers / cattle herders be forewarned to shift cattle away from low lying areas adjacent to River Chenab and its associated Nullahs.
- g. Restrict vehicle movement in low lying areas / at-risk areas, close to water channels / nullahs and River Chenab.
- h. Provision of POL for back-up generators at water pumping stations and timely pre-placement of de-watering equipment to flooding.
- i. DISCOs and relevant Local Administration / Departments to ensure that necessary arrangements are undertaken to avoid electrocution incidents and timely restoration of power supply.
- j. Provision of relief / medical supplies to affectees in timely manner.

- k. Coordinate with concerned departments for clearance of roads in case of any blockage / obstruction, waterlogging and pre-placing of necessary emergency equipment at vulnerable / appropriate locations
- l. Travelers and Tourists are forewarned about risks posed at flood vulnerable locations and may be diverted to safe lay-by / waiting areas with sufficient supply of water / food and essential medicines in case of adverse / dangerous road conditions by Police, NH&MP and Local Administrations.
- m. In case of any eventuality, special SITREP / update be shared immediately with NDMA.
2. **Flood Forecasting Division Only**. Please share regular updates on water flows on major rivers, especially River Chenab every 3 hours with NDMA.
3. **Press Information Department Only**. With the request for wider circulation and public awareness.
