#### TENDER NOTICE

### HIRING OF SECURITY AGENCY FOR NDMA WAREHOUSES

National Disaster Management Authority (NDMA), Islamabad invites sealed bids from well reputed firms / companies for Hiring of Security Agency for NDMA Warehouses.

The firm must be registered with Income Tax and Sales Tax Departments. The interested firms should be technically as well as financially sound.

The tender documents including instructions / terms and conditions may be collected from Admin Section (Room No.234-B, Prime Minister's Office, Islamabad) during office hours on payment of Rs. 2000/- in the shape of cash or may be downloaded from PPRA / NDMA websites (i.e. <a href="www.ppra.org.pk">www.ppra.org.pk</a>. / <a href="www.pww.ndma.gov.pk">www.ndma.gov.pk</a>).

The bids must reach the Undersigned before 1130 hours on 12<sup>th</sup> November, 2020 which will be opened the same day at 1200 Hours.

#### **GENERAL TERMS AND CONDITIONS**

The National Disaster Management Authority requires security services for its warehouse, located at Islamabad (8 x Guards) and Karachi (4 x Guards) for 12 hrs shift on following terms and conditions:-

- 1. The firm should be registered with Income Tax & Sales Tax Department (Registration Numbers should be clearly mentioned and valid documentary evidence be attached).
- 2. The firm should have a minimum of five (05) years experience of providing security service and should have a proper setup / office at Islamabad / Rawalpindi and Karachi.
- 3. The bidder will be required to submit a Pay Order / Demand Draft @ 5% of the total value of the contract (12 x months), as earnest money in the name of Director (Administration), NDMA Islamabad.
- 4. Earnest Money of unsuccessful bidders will be returned / refunded after award of contract to successful bidder(s). However, Earnest Money of successful firm(s) will be converted into "Security Deposit".
- 5. The firm must be a license holder issued by Ministry of Interior or any other concerned Division.
- 6. The bids must reach the undersigned upto 12.00 am on 10<sup>th</sup> November 2020 which will be opened at 12:30 pm on the same day in presence of representative of security agency.
- 7. The contract will be awarded to the lowest evaluated bidder.
- 8. Submission of false statement / documents as well as concealing of any information is liable to disqualify the respective firm(s).
- 9. During the currency of the contract, the firm will provide Security Services as per terms and conditions, to be settled later on in the shape of contract agreement between both parties.
- 10. The Authority reserves the right to accept or reject all or any of the tenders as per PPRA Rules.
- 11. Duration of the contract will be for initial period of 2 x years, however, the same may be further extended with mutual understanding of both parties.
- 12. The company shall preferably provide ex-serviceman / Police (Sepoy to Havildar) security guards under 50 years of age with good health along with physical fitness certificate.
- 13. Initially 12 x security guards for 12 x hours shift at following sites are required however the same may also be increased or decreased as per requirement:-

- 14. The company shall provide attested copies of Military Discharge Certificates, NIC and security clearance of the security guards in case of retired military personnel.
- 15. The duty will be round the clock and 07 days a week.
- 16. The company shall be responsible to make payment of salaries to its staff in time from its own resources without waiting for the release of cheque by NDMA.
- 17. The company will be responsible to provide necessary uniform, proper weapons and security gadgets to the security guards.
- 18. A performance certificate by two major clients where the firm has been providing security services in the last 03 years.
- 19. Weightage of Technical and Financial proposals will be 70% and 30% respectively.
- 20. During the technical evaluation no amendments in the technical proposal shall be permitted;
- 21. Firm will be responsible in case of any theft where security guard is found guilty or any negligence on the part of security guards reveals.
- 22. The financial proposals of technically qualified bids will be opened publicly at a time, date and venue announced and communicated to the bidders.
