- 1. Tender Identification Number: Tender No. 7/Coronavirus-2020
- 2. Title of Tender: Procurement of Items / Equipment for Preparedness of Coronavirus
- 3. **Pprocuring Agency**: National Disaster Management Authority Prime Minister's Office Islamabad.
- 4. Last Date & Time for Submission of Applications: 8th April 2020 at 1100 Hours.
- 5. Opening Date & Time: 8th April, 2020 at 1130 hours.
- Opening Address: Room No. 220-E, National Disaster
 Management Authority (NDMA), Prime Minister's Office, Islamabad.
- 7. Period of Contract: As per mutual agreement/satisfactory delivery.
- 8. Rejection of Applications: Application on following accounts to be rejected:
 - a. Incomplete and conditional applications will be rejected forthwith.
 - b. Applications received after due date & time of submission will not be accepted.
- 9. Applicant's Mandatory Qualifications / Prerequisites:
 - a. Registered with Income Tax Department and Sales Tax Department.
 - b. In case of authorized supplier / agent, certificate from original manufacturer will be required.
 - a. Must have at 5 years relevant experience in the market.
 - b. An affidavit that the Firm / Company has never been blacklisted by any Ministry / Division / Department / Organization of the Government of Pakistan in the past.
 - c. Bank Statement FY 2018-19
- 10. Supporting Documents: Following supporting documents are required:
 - c. Income Tax Registration Certificate
 - d. Daily or monthly delivery capacity.
 - e. Company Profile including proof of existence in particular business.
 - f. Details of past business experience with various clients to include quantities supplied.
 - g. List of others business and products if any.
 - 11. **Specification:** All, firms /vendors shall quote their standard specification acceptable to Drug Regularity Authority and other relevant authorities of Pakistan as well as comply with International standard.

However, firms may quote their own standard specification and highlight unique /distinctive features if any .NDMA requirement may vary (increase or decrees) due to the requirement on need basis in case of disaster.

- 12. **Draft Contract Agreement:** Draft contract agreement as per appendix-**A**
- 13. Award of Contract / Supply Order: Competitive bidding will be done through Single Stage One Envelop System as per PPRA Rules. The firm offering overall lowest bid against items of required quantity and specifications will be awarded the Contract / Supply Order.
- 14. **Earnest Money**: The selected / shortlisted firms shall only be required to submit Earnest Money @ 2% of their respective bid value in the name of Director (Administration), NDMA. However, the same will be returned in case of rejection.
- 15. **Maximum Time of Delivery**: The selected firms would be liable to deliver their respective items within the stipulated time period.
- 16. **Payments**: Payment will be processed after satisfactory delivery of the required items as per supply contract / agreement.
