National Disaster Management Authority (NDMA), Islamabad invites sealed bids from well reputed firms for supply of 1.23 Million (One Million Twenty Three Hundred Thousand) x SARS-CoV-2 Antigen Detection Rapid Diagnostic Test (Ag-RDT) for Coronavirus testing:-

NDMA will follow Single Stage Two Envelop procedure as per PPRA Rules. The firms must have capacity to deliver/provide within agreed time period.

However, the same would be returned in case of rejection. Letter of Acceptance (LOA) from principal manufacturer should be issued addressed to National Disaster Management Authority. Annual turnover of firm should also be mentioned.
