TERMS AND CONDITIOINS For Procurement of Relief Items

2. Title: Procurement of Relief Items, through "SINGLE

STAGE TWO ENVELOPE METHOD".

3. Procuring Agency: National Disaster Management Authority, Islamabad

Last Date & Time for Submission of Applications: 23rd June, 2023 at 1300 Hours.

5. Opening Date & Time: 23rd June, 2023 at 1400 hours.

7. Time / Bid Validity: Bid validity shall be 90 days from the date of opening of bid

8. Rejection of Applications: Application on following grounds to be rejected:-

a. Incomplete and conditional bids will be rejected forthwith.

b. Applications received after due date & time of submission shall not be accepted.

9. Applicant's Mandatory Qualifications / Prerequisites:

- a. Registered with Income and Sales Tax Department.
- b. The original manufacturers having own production units would be preferred.
- c. Firms having experience of similar supply would be preferred.

10. Supporting Documents:

- a. Company details including manpower, strength and annual business turnover for last 5 years.
- List of all products including details of per day manufacturing capacity, location of warehouses and present level of stocks of each product.
- c. Total annual average international sales turnover for each of the last three years as documented by audited financial statements.
- d. Total annual average domestic sales turnover for each of the last three years as documented by audited financial statements.
- Income and Sales Tax Registration Certificates.
- f. Company Profile including proof of existence in particular business.
- g. An affidavit that the Firm / Company has never been blacklisted by any Ministry / Division / Department / Organization of the Government of Pakistan in the past.



- h. Details of past business experience with various clients to include quantities supplied.
 - i. Average holding level of each product in the warehouse throughout the year.

11. Production Capacity:

- a. Total annual production capacity for the product the manufacturer is offering to supply.
- Details of manufacturer's on-site quality assurance testing facilities.
- Number of similar contracts in last five years.
- 12. <u>Specifications:</u> Specifications of the items is given at **Annex-A**, to this document. For any query please contact Director (Logistics) / Secretary (Technical Committee), NDMA Ph # 051-9204493.
- 13. **Submission of Bid.** The bid shall comprise two envelopes submitted simultaneously, "Technical proposal" and "Financial proposal". Both the envelopes should be enclosed together in an outer single envelope.
- 14. Draft Contract Agreement: Draft contract agreement is at Annex-B.
- 15. Quoted Price: Interested firms are advised to quote their rate in PKR both unit price as well as total bid value inclusive of all applicable government taxes and transportation anywhere in Pakistan as per advice of NDMA. No cutting / overwriting is allowed.
- 16. Evaluation of bid / Award of Contract: Firm will be shortlisted after technical and financial evaluation. In first phase the envelope marked with "Technical proposal" shall be opened in the presence of available bidders or their representatives. Financial proposal of only technically compliant firms shall be opened, whereas, financial proposal of technically non-compliant firms shall be returned unopened to the bidders. Firms may be asked to submit their samples before Technical Committee of NDMA for visual inspection, if required by the Technical Committee of NDMA. NDMA may send the samples to any designated laboratory for lab testing on the expense of the firms. The most advantageous bidder will be awarded the Contract / Supply Order. NDMA reserves the right to reject all the bids or to annul the bidding process under PPRA rules prior to the award of contract.
- The firm shall submit earnest money/ bid security amounting to Rs.1.0 Million (One Million only) each for De-watering Pumps and Boats whereas Rs.0.5 Million only for Life Jackets in favour of Director (Procurement), NDMA in the shape of pay order or demand draft, cross Cheque is not acceptable. The bid security shall be attached with the technical proposal. The earnest money of the successful bidder will be retained till signing of contract / submission of bank guarantee. Earnest money of the unsuccessful bidder shall be

- ronned to them. Any bid not accompanied with bid security shall be declared as non-responsive. The earnest money of the bidder shall be forfeited, if it draws its bid during bid validity period or till signing of contract with the most advantageous bidder.
- 18. <u>Maximum Time of Delivery:</u> The firm shall clearly mention readily available stock, delivery time period in their bids. The successful contractors shall deliver the items within mutually agreed time period given at the work order.
- 19. Payments: Payment will be processed after satisfactory delivery with inspection report signed by the end user of the required items as per supply / work order / contract agreement.
